Governor's Directed Health Measure Extended Until September 13 Panhandle total: 606, Active: 105, Recovered: 495, Deaths: 6

Unified Command confirms 21 more cases of COVID in the Panhandle. The investigations are underway, all close contacts will be quarantined and actively monitored for symptoms by public health officials.
